Minutes of the February 7, 2023 Board Meeting

Present:

H. Michael Ziegenfuss (Chair), Marianne McKay (Vice Chair), Atoy Carrington (Secretary), Stephanie Iles (Director of Elections & General Registrar), Rosanna Benchoach (Deputy Director of Elections & Deputy Registrar), Jaylin Drewry (Visiting Representative from Norfolk State University).

The Norfolk Electoral Board was called to order by Mr. Ziegenfuss on Tuesday, February 7, 2023 in the Elections Office Board Conference Room in Norfolk's City Hall at 10:07am.

Approval of Minutes from the Special Elections Canvass, January 11 & 13, 2023:

Ms. McKay moved to approve the minutes from the January 11 & 13, 2023 Special Election Canvass, which was seconded by Ms. Carrington. The Board unanimously approved the minutes.

Discussion Pertaining to a Possible New Polling Location:

Ms. Iles introduced guest Mr. Jaylin Drewry (Co-Chair Student Advisory Committee and Immediate Past SGA President) of Norfolk State University to discuss the potential of having a polling location on the campus of Norfolk State University that would be used exclusively by and for the student residents.

The Board agreed to meet with additional staff of Norfolk State University on Tuesday, February 28, 2023, to view possible locations on campus that would meet legal and logistical requirements.

Approval of Officers of Elections:

Ms. McKay moved to approve the list of thirty-six (36) Officers of Election as submitted by Ms. Iles. This brings a total of six hundred seventy-four (674) Officers of Election for a term ending February 28, 2025. Ms. Carrington seconded the motion. The Board unanimously approved the list of Officers of Election as submitted by Ms. Iles.

National Voting Rights Act Purge:

Ms. Iles informed the Board that 3,425 citizens in Norfolk have been removed from the voter registration rolls by the Virginia Department of Elections as regular maintenance due to their inactivity.


Such other business as may come before the Electoral Board:
